I understand that the sports of skiing, snowboarding and other recreational activities involve inherent and other risks of **INJURY** and **DEATH**. I voluntarily agree to expressly assume **all risks of injury or death** that may result from skiing/snowboarding/ or other equipment use.

I agree to release the ski/snowboard shop, Hoodoo Ski Area and its employees, owners, affiliates, agents, officers, directors and the manufacturers and distributors of this equipment (collectively "PROVIDERS") from all liability from injury, death, property loss and damage which results from the equipment user's participation in the sport of skiing/snowboarding/other recreational activity, or is in any way related to use of this equipment, including all liability which results from the negligence of providers, or any other person or cause. I further agree to defend and indemnify PROVIDERS for any loss or damage, including any that results from claims or lawsuits for personal injury, death, and property loss and damage related in any way to the use of this equipment.
